## 1. Instruction to the Bidder

- i. Government Polytechnic Khagaria may, in its absolute discretion, seek additional information or material from any bidder after the RFP closes and all such information and material provided must be taken to form part of that Respondent's response.
- ii. Bidder should provide details of their contact person, telephone, fax, email, and full address(s) to ensure that replies to RFP could be conveyed promptly.
- iii. The selection process would be based on L1 criteria where full weightage would be given to financial bid only.
- iv. The bidder should be an ISP having valid ISP license. The bids not complying with this criterion will not be considered for financial evaluation.
- v. The bid prepared by the Bidders, as well as all correspondence and documents relating to the Bid exchanged by the Bidder and the Government Polytechnic Khagaria and supporting documents and printed literature shall be written in English.
- vi. Queries / Clarification if any, may be taken up with the contact person detailed below, on or before 25/06/2024 between 10 am to 5 pm on Monday to Friday:

- vii. The ISP should have fully resilient and self-healing network architecture, for the domestic back-up.
- viii. In the event of the specified date for the submission of bids, being declared a holiday for the Government Polytechnic Khagaria, the bids will be received up to the appointed time on the next working day.
- ix. The Government Polytechnic Khagaria >may, at its discretion, extend the deadline for submission of Bids by amending the Bid Documents, in which case, all rights and obligations of the <Name of Institute> and Bidders previously subject to the deadline will thereafter be subject to the deadline as extended.
- x. Government Polytechnic Khagaria shall in no circumstance accept any bid after the deadline for submission of bids prescribed by the Government Polytechnic Khagaria and would summarily be rejected.
- xi. The price quoted should be in Indian Rupees inclusive of all charges/taxes etc.
- xii. No cost shall be payable related to transportation and Insurance.
- xiii. Any deviation may lead to bid rejection. Government Polytechnic Khagaria reserves its right to cancel the order in the event of one or more of the following conditions:
  - a. Delay in installation & commissioning of the system beyond 5 weeks from the date of acceptance of the work order.
- xiv. Average latency should not be more than 100 ms up to ISP's 1<sup>st</sup> peering Point.
- xv. The ISP must have adequate local support facility to provide 24 X 7 X 365 customer support:
  - a) The ISP should have centralized trouble ticketing tool for call logging, monitoring and troubleshooting purpose.
  - b) The ISP should have single Toll-Free number/Help Desk for all the call logging and status update.
  - c) The ISP should have well defined capabilities and procedures to track call resolution Progress status and provide the updates to the customer.
  - d) In addition, ISP should have well defined management and technical escalation procedures.
  - e) The ISP should assign one SAM (Service Assurance Manager) for the customer.



- f) The ISP has to provide Software Tool/Method to measure/check the Internet Bandwidth provided by the bidder.
- g) The ISP has to provide monthly MRTG Report of usage of Bandwidth and will ensure that getting 500 Mbps (Polytechnic Institute)/ 1 Gbps (Engineering College) Mbps (1:1) Bandwidth.
- h) The bidder is required to offer Service Level Agreement (SLA) for the proposed Link along with a guaranteed uptime commitment of 99.5%.
- xvi. Time and quality of the service are the essence of this agreement. Failure to do so will be considered as breach of the terms and conditions of the contract.
- xvii. By submitting a proposal, the Bidder agrees to promptly contract with Government Polytechnic Khagaria for any work awarded to the Bidder. Failure on the part of the awarded Bidder to execute a valid contract with Government Polytechnic Khagaria will relieve Government Polytechnic Khagaria of any obligation to the Bidder.
- xviii. If a Bidder makes any statement or encloses any form which turns out to be false/incorrect at any time i.e. during the evaluation of the Bid / even after placing the Work Order (WO). Bid/PO will be rejected/cancelled and suitable action will be taken.

## 2. Scope of Work

Government Polytechnic Khagaria seeks proposals from qualified Internet service providers to provide Internet leased line connection as per below mentioned specifications:

- i. Requirement of 500 Mbps internet bandwidth for (Government Polytechnic Institutes)/ 1Gbps internet bandwidth for (Government Engineering Colleges) with uncompressed, unshared leased line connectivity at all the time.
- ii. Bandwidth with 1:1 uplink & downlink ratio
- iii. Average Network packet loss  $\leq 0.5\%$
- iv. Consistency in required bandwidth.
- v. Support services 24\*7\*365
  - a) The ISP should have an extremely reliable network and redundancy is expected at all levels.
  - b) Router, Mux/Modem, and any other hardware required to be provided by ISP.
  - c) Maintenance of Hardware supplied by ISP will be the responsibility of ISP only.
  - d) Cost related to hardware/software and other required materials shall be borne by the Bidders only.
  - e) Technical Requirements:

Government Polytechnic Khagaria requires Internet bandwidth as per the following specifications:

- i. The delivery should be through a public static IP address and should be able to create a network with a pool of minimum 8 public IPv6.
- ii. ISP shall provide single CPE with single download link to customer equipment.
- iii. Average latency should not be more than 100 ms up to ISP's 1<sup>st</sup> peering Point. Latency beyond 100 ms shall be subject to penalty.

The Technical proposals of all bidders which meet the above eligibility criteria, and basic requirements (i.e., timely submission, bid security, etc.), will move to the next stage of evaluation, in which technical score shall be computed based on the Scoring matrix as specified below:

#### 5. Financial Evaluation

Financial bids shall be opened only for the vendors whose bids are found to be Technically fit/ substantially responsive and complying with minimum eligibility criteria.

- i) Government Polytechnic Khagaria will open the Financial Bids of only Technically Qualified Bidders, in presence of the Nodal Officer / designated representatives of the Bidder who choose to attend, at the time, date and place, as decided and communicated by Government Polytechnic Khagaria .
- ii) If there is any discrepancy in the financial bid, it will be dealt as per the following:
  - a. If, in the price structure quoted for the services, there is discrepancy between the unit price and total price (which is obtained by multiplying the unit price by the quantity) the unit price shall prevail and the total price corrected accordingly.
  - b. If there is an error in a total corresponding to the addition or subtraction of subtotals, the subtotals shall prevail, and the total shall be corrected.
  - c. If there is a discrepancy between words and figures, the amount in words shall prevail.
  - d. If there is such discrepancy in an offer, the same shall be conveyed to the bidder with target date up to which the bidder has to send his acceptance on the above lines and if the bidder does not agree to the decision of Government Polytechnic Khagaria , the bid is liable to be rejected. If the Bidder does not accept the correction of errors, its bid will be rejected and the EMD may be forfeited.

#### 6. Contract period

Initially for Three-Years which will be extended yearly on the mutually agreed terms and conditions between the two parties.

#### 7. Performance Security

- a. The successful bidder shall have to furnish a performance security equivalent 5% of the Project cost, in the shape of a Bank Guarantee issued by a scheduled Bank in favour of Principal, Government Polytechnic Khagaria . The Bank guarantee shall be as per proforma at "Annexure 4" and remain valid for a period, which is six months beyond the date of expiry of the contract. The Performance Security will be returned to the bidder, upon validation of completion of all contractual obligations including warranty.



- b. The performance security should be submitted before executing the contract /signing of the contract document positively.
- c. If the bidder violates any of the terms and conditions of tender document of this Notice Inviting Tender/Tender in any manner, the Performance Security shall be liable for forfeiture, wholly or partly, as decided by the Government Polytechnic Khagaria and the contract may also be cancelled/terminated. Further, the bidder may be blacklisted for a reasonable period as decided by the Department of Science, Technology and Technical Education/ Government Polytechnic Khagaria.

#### 8. Inspection of Site and Equipment

The interested bidder may visit the Government Polytechnic Khagaria , where the services are to be rendered, till last date. The bidders must familiarize themselves with local conditions and take these into account while preparing their proposal. The Government Polytechnic Khagaria shall not be liable for any expenditure incurred in such inspection or in the preparation of the bid(s).

#### 9. Tendering Expense

The bidder shall bear all costs and expenditure incurred and/or to be incurred by it in connection with its tender including preparation, mailing and submission of its tender and subsequently processing the same. The Government Polytechnic Khagaria will, in no case be responsible or liable for any such cost, expenditure etc. regardless of the conduct or outcome of the tendering process.

#### 10. Language and currency of the tender

The tender submitted by the bidder and documents relating to the tender shall be written in the English language and the bidder is required to quote all prices strictly in Indian Rupee only.

#### 11. Amendments to Tender Documents

At any time prior to the deadline for submission of tenders, the Government Polytechnic Khagaria may, for any reason deemed fit by it, modify the Tender Documents by issuing suitable amendment(s) to it. Such an amendment will be notified on [eproc2.bihar.gov.in](http://eproc2.bihar.gov.in) and the same shall be binding to all prospective Bidders. Government Polytechnic Khagaria will not issue any separate communication in this regard.

#### 12. Bid Validity

The submitted bids shall remain valid for a period of 180 days after the due date of submission of bids.

#### 13. Rejection of bid.

Bids shall be rejected if :-

- Not found in prescribed format and not containing required details.
- Not properly signed as per requirements.
- Received after due date and time.
- Missing of any supporting document(s).

#### 14. Subcontracting

No subcontracting allowed under this contract.

#### 15. Termination of Contract

- Bidder fails to install and commission the Internet link at the designated location within the stipulated time as per contract or within any extension thereof granted by the Government Polytechnic Khagaria

- Shortfall in achieving the Service Level requirement successively in two quarters or any three quarters in a financial year.
- Bidder fails to perform any other obligation(s) under the contract.
- Any threat is perceived or observed on the security of Government Polytechnic Khagaria data / property out of any action by the staff deployed for monitoring / configuration etc., by service provider.
- However, either party, in the case of termination, will give 1 month notice to the other party.
- The Government Polytechnic Khagaria may, at any time terminate the contract by giving written notice to the Service provide if the service provider becomes bankrupt or otherwise insolvent. In this event, termination will be without compensation to the Service Provider, provided that such termination will not prejudice or affect any right of action or remedy which has accrued or will accrue thereafter to the Government Polytechnic Khagaria .

#### 16. Notices

Notice, if any, relating to the contract given by one party to the other, shall be sent in writing by hand or e-mail or post. The addresses of the parties for exchanging such notices will be the addresses as incorporated in the contract between the Government Polytechnic Khagaria and the bidder/agency.

#### 17. Resolution of Disputes

- Any dispute or difference or claim arising out of or in relation to this Agreement, will be settled by reaching a mutual understanding between the parties.
- If any further dispute arises between the parties thereupon, the same will be settled as per the extant law of land through the competent court of law under the territorial jurisdiction of <Khagaria> only.

#### 18. Applicable Law

The contract shall be governed by and interpreted in accordance with the laws of India for the time being in force.

#### 19. Payments

- Any payments would start from successful commissioning of the link and mitigation services.
- Bidder [Service Provider] will be paid in quarterly equal instalments as per agreed terms and condition with the Government Polytechnic Khagaria .
- Any payment made will be linked with the Service level agreement. Any penalty would be adjusted in the quarterly payment.
- Payment will be made after deducting TDS/other charges.
- In case the contract is terminated, payment towards services will be made on pro rata basis, after deducting applicable penalty and TDS/other.

#### 20. Insurance

All the delivered hardware will be owned by the Bidder [Service Provider] during the entire period of the contract, the service provider will take insurance for all the network hardware items installed in the premises of Government Polytechnic Khagaria for the entire duration of the contract period against all risks.

## 21. Schedule of Work

The project must be completed within a period of 5 weeks from the date of the order. The vendor is expected to have regular meetings with Government Polytechnic Khagaria and inform the progress of work.

## 22. Service Level Agreement (SLA)

Service Level Agreement (SLA) shall become the part of contract between Institute and the Successful Bidder. SLA defines the terms of the successful Bidder's responsibility in ensuring the timely delivery of the deliverables and the correctness of the same based on the agreed Performance Indicators as detailed in this section. The successful Bidder has to comply with Service Levels requirements to ensure adherence to project timelines, quality and availability of services.

The purpose of this Service Level Agreement (hereinafter referred to as SLA) is to clearly define the levels of service which shall be provided by the Bidder to Institute for the duration of this contract.

### 22.1. Penalty

1. During the entire contract period the Bidder should guarantee Link availability during normal business hours as mentioned in SLA on monthly basis. Government Polytechnic Khagaria will impose penalty as given below:

Link Availability	Penalty in % of quarterly Payment
100% to 99.5%	NIL
Below 99.5% Up to 98.5 %	2% of the quarterly payment
Below 98.5% -Upto 97%	5% of the quarterly payment
Below 97%- Upto 95%	7% of the quarterly payment

- In the event of non-provisioning of connectivity at Government Polytechnic Khagaria even after extension of delivery date. Penalty at 1 % of the annual cost of the link will be charged for every week's delay subject to maximum of 10%.

2. Average latency should not be more than 100 ms up to ISP's 1<sup>st</sup> peering Point. Latency beyond 100 ms shall be subject to penalty which would be fixed by the principal/principal in-charge of Government Polytechnic Khagaria

### 22.2. Exclusions

Down time due to following situations will not be considered for the purpose of penalty calculation:

- Schedule maintenance by the service provider with prior intimation
- Link down due to power failure at <Name of the Institute> location/office
- Force majeure events
